Whereas

Sumantai Wasnik Institute of Nursing, Shivpriya Nagar opp Ganesh Nagar, Dabha Nagpur – 440023 of the ONE PART is affiliated to Maharashtra University of Health Sciences, Nashik. Recognized by Indian Nursing Council, New Delhi and Maharashtra Nursing Council Mumbai has asked for clinical training of its B. Sc Nursing students, including their university practical exam at Wockhardt Hospital throughout their academic session.

The terms and conditions of agreement will be as given below.

1. The agreement will be valid for the period of 1 (One) Year from the date of agreement i.e. August 01, 2022 to July 31, 2023.
2. The students will have to abide by the code of conduct.
3. No patient detail is to be used for any other purpose other than academic restricted to the First part institutional study.
4. The hospital reserves the right to discontinue any student and take disciplinary action as deemed fit for the action and misconduct performed during the course of training at Wockhardt Hospital Ltd, Nagpur.
5. The clinical training in no way should harm any admitted patient or cause any discomfort of any nature to the patient.
6. The confidentiality of patients and patient's right to be adhered to during the course of students training.
7. The students will have to abide by hospital polices such as POSH, Misconduct and other applicable hospital polices.

8. Sumantai Wasnik Institute of Nursing Nagpur shall:

- (i) comply with all applicable laws, statutes, regulations relating to anti-bribery and anti-corruption including but not limited to the Bribery Act 2010/FCPA 1977 and not engage in any activity, practice or conduct which would constitute an offence under the Bribery Act 2010/ FCPA 1977/ prevention of corruption laws in India, if such activity, practice or conduct had been carried out in the UK/the USA/India or elsewhere;
- (ii) comply with the Wockhardt Hospitals Anti-Corruption and Bribery Policy;
- (iii) promptly report to Wockhardt Hospitals any request or demand which if complied with would amount to a breach of either this Agreement or the Wockhardt Hospitals Anti-Corruption and Bribery Policy;
