

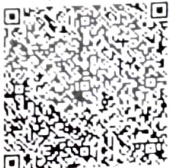

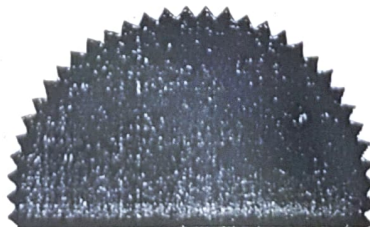

The Maharashtra Nursing Council (MNC) examined the documents submitted by Sumantai Wasnik College of Nursing, Nagpur for permission to start New B.Sc.(N) programme for the academic year 2011-2012. Maharashtra Nursing Council conducted inspection of the institution by a team of inspectors appointed by the Council on 10/09/2011.

The Council in its Executive Committee Meeting held on 26/09/2011 resolved on the basis of the inspection report that the said institution is permitted to start New B.Sc. (N) programme for the academic year 2011-2012 with an Intake capacity of 30 (thirty) students subject to fulfillment of the following conditions.
